## BYLAW #701

### A BYLAW TO SET SEWER USER RATES FOR 2007

WHEREAS section 193 of the *Community Charter* SBC Chap. 26 empowers the Council of the Village of Warfield to impose a fee in respect of a service provided, and

WHEREAS it is Council's policy that a fair and reasonable share of the cost of operating and maintaining the sanitary sewer system is recovered by way of a user rate charged to those users of the sanitary sewer service on whom a sewer parcel tax is not imposed,

NOW THEREFORE, the Council of the Village of Warfield, in open meeting assembled, hereby ENACTS AS FOLLOWS:

#### SHORT TITLE

1. (1) This Bylaw may be cited as the "2007 SEWER USER RATE BYLAW".

#### USER CHARGE SCHEDULE

2. (1) The following sanitary user charges shall apply:

(a) Apartment suite or duplex, for the first unit	\$ 205.00
Apartment suite or duplex, for each additional units	\$ 34.20
(b) Motel, for the first room	\$ 205.00
Motel, for each additional room	\$ 20.50
(c) Cafes and Restaurants	\$ 205.00
(d) Garage or Service Station	\$ 205.00
(e) Stores or Business Premises	\$ 205.00
For each residential dwelling unit in conjunction with Stores or business premises	\$ 20.50
(f) Schools, for the first classroom	\$ 205.00
Schools, for each additional classroom	\$ 20.50
(g) Trailers and Mobile Homes in Trailer Parks, for the first space	\$ 205.00
for each additional space	\$ 34.20
- (2) The charges established with this Bylaw shall be invoiced prior to May 31, 2007.
- (3) Where an account invoiced pursuant to this Bylaw remains unpaid on December 31, 2007, the outstanding balance shall be transferred to the corresponding property tax account effective December 31, 2007.

**ENACTMENT**

- 3. (1) If any section, subsection, sentence, clause or phrase of this Bylaw is for any reason held to be invalid by the decision of a court of competent jurisdiction, the invalid portion shall be severed and the part that is invalid shall not affect the validity of the remainder.
- (2) This Bylaw shall come into full force and effect on the final adoption thereof.
