**BYLAW #875**

A BYLAW TO AMEND POOL USER FEE BYLAW, NO. 851

WHEREAS section 194 of the *Community Charter* authorizes Council to impose fees for the use of municipal property, and

WHEREAS section 12 of the *Community Charter* authorizes Council to establish variations, terms and conditions, and

WHEREAS the Council of the Village of Warfield deems it necessary to revise the admission rates to pool,

NOW THEREFORE, the Council of the Village of Warfield, in open meeting assembled, hereby ENACTS AS FOLLOWS:

**Short Title**

1. (1) This Bylaw may be cited as the "**Pool User Fee Amendment Bylaw, No. 875, 2019**"

**Amendment**

2. (1) That Schedule 'A' of Pool User Fee Bylaw, No. 851 is hereby deleted and replaced with a new Schedule 'A' attached to and forming part of this Bylaw.

**Enactment**

3. (1) If any section, subsection, sentence, clause or phrase of this Bylaw is for any reason held to be invalid by the decision of any court of competent jurisdiction, the invalid portion shall be severed and the part that is invalid shall not affect the validity of the remainder.  
  
(2) This Bylaw shall come into full force and effect on final adoption.
